4. Public participation

parishioner asked for an update about the repairs in Smallgains Lane, due to the flooding and potholes. P Fenwick discussed with residents present, what Stock Parish Council had done in February to help with the flooding and advised that the next stage is Highways to fill the potholes and Essex Waterways to look at the ongoing issue of flooding in this area. **ACTION: G Fullam to call Essex Highways to see if they can rearrange the pothole fixing before road closure planned in Well Lane**

Another parishioner confirm that the private footpath that runs from Mill Road to Well Lane will be sorted on 2nd week April as it's in a poor state and hard for anyone to get past Another parishioner asked for an update on parking and P Fenwick handed over to Councillor J Pye to update parishioner present. J Pye said he has submitted parking restrictions to the centre village and school side of B1007. Did this on 20thFebruary. Had a meeting with Traffic Regulation Order (TFO) team, SEPP School and Pre School.

School were very helpful and wanting to get a solution. 3PR scheme is being looked into with the school and SEPP. R Panther who works for SEPP has been really helpful. On site meeting with Andrew Clay in April, to look at what is possible with parking restrictions. SEPP and TRO will be coming to stock on a regular basis to enforce the parking restrictions.

R Pritchard mentioned about looking at having permits for residents might be better than yellow lines from experience where he has lived before.

P Fenwick Yellow lines are ignored so they have to be enforced 1st and then look to extend parking restrictions in other areas. M Rolph said the yellow lines are there for safety concerns on the junctions.

A residents said can Stock Parish Council put a letter on the car's that park on the double yellow lines to be more considerate and follow the highway code. M Rolph mentioned that this had been looked into before but we aren't allowed to touch other people's property and it could hold us liable to damage of a vehicle

A resident has asked, have they agreed to give you feedback on how many attendance they are making. See how many times they have come in and how often. John Pye will keep pushing it.

Parking

- Speeding & Road Safety

PO's raised Well Lane & Zebra Crossing G Fullam paid the invoice for Well Lane and Zebra Crossing LHP's cheque to be raised £973.10 & £736.40

 Survey results on High Street question are split 50/50 next steps. Did councilors want to make a change to the LHP to be 20mph instead of 30mph, but still to have average speed camera's. All councilors present voted in favor of changing it to 20mph ACTION: G Fullam to email J Simmons to change the LHP form for the High Street to be 20mph with Speed camera. Also to send the letters from Freddie Coleman's family that they received from local MP's.

R Pritchard discussed the event on 16^{th} March 'Stock Against Speeding' and asked parishioners present to attend.

A parishioner mentioned that the pinch point in the road by Mill Road is not sufficient enough and is less then 8 meters wide.

ACTION: M Gray to notify the police of the 'Stock Against Speeding' event.

ACTION: G Fullam to send articles of 'Stock Against Speeding' to support LHP forms.

- Black Posts near Paddocks entrance have been damaged.

3 down the High Street are damaged or missing. The councilors discussed in detail but came to the conclusion that they believe they are Highways responsibility.

ACTION: G Fullam to report the posts damaged or missing to Essex Highways

- Footpath Common Road by Doctors – parishioner has asked if this could be possible

Councilors discussed that they believe it the land is owned by Lord Peter and we would need to seek permission and then go to the Conservation Officer for approval even through it would be a temporary type footpath

A resident mentioned that it's a Registered Village Green.

Speed Watch

- Training update & Speed Watch Group

M Rolph advised 10/11 trained up already. 10 volunteers that weren't able to attend the original training session. Arranged another training session for 21st March to all volunteers.

A resident asked how does it get reported and what authority does speed watch have. M Rolph stated we have a special report we have to fill in and send to SEPP. They then send a letter to the speeding motorist. The police will also attend sessions and can fine on the spot

One of the speed watch volunteers asked if it would be possible to set up a rota of advanced dates.

ACTION: M Rolph to set future dates rota

- Painting S Porter Swan Lane sign removal

- New wooden post for Stock Sign Cheque to be raised for £258.10
- Lushhill post & Common Post Swift to confirm start date
 Ones to be repaired on left hand side going out of stock. On the right hand side haven't been installed. The earth would be dug away from the gabion basked and put on the other side to raise the area and would need to be planted. Posts would be put along the side of the gabions basket and infilled with type 1 to improve the drainage. Waiting for Swift to send through

quotation for the digging out of the earth. The posts are already in the previous quote.

Environment

Hankins Wood

- P Fenwick update from our solicitors
- P Fenwick informed everyone we have received the tailor made Insurance policy. We would need to extend the insurance policy we already have.
 P Fenwick read through the repair. It was discussed that maybe the person who has written it has not been to the wood as no grass in the wooded area. Also to keep dogs on the lead. Council would need public liability for £10Million ACTION: Paul to contact insurance and reply back on the issues raised in the email as everyone was not happy with what was on it.

The Common Tree Survey, Drainage and Car Park Project.

- Work has begun on the Drainage 16/01/23 update on project
 - 1st stage has been down the gabion cage. Works to the car park still to be done as it the swale, grips drainage from the common into the gabion cage and the ditch going around the common to be dug out. Waiting for the weather to be dry. Digging the ditch round the side to the back. Plus the posts adjacent to the Common. J Pye mentioned the drain has still not been cleared by highways.

ACTION: P Fenwick to see if Swift can clear the drain

Look at the dead tree by the nook and can this be removed

Bus Shelter

- Agreed Cost of 10K in November meeting. M Gray to confirm when work will start

M Gray - Cost have increase by £4520 now looking at £14K doesn't include instillation, traffic lights while the work is done and licenses to work on public highways. Going to come to approx. 20K. Same company that did the shelter to the Hoop and by JW roundabout. Go down and do a condition survey and see if this can be refurbished. Missing pieces of wood.

- ACTION: M Gray to complete a condition survey with P Fenwick and bring back to committee meeting

Trees

- Raised a planning application for TPO tree on the common to be reduced D Swift will remove the dead tree that is pushing into the fence of a neighbor ACTION: G Fullam to remove from agenda and just liaise with the resident
- Plant Queen's tree & check tree's from previous year are ok to plant Swap it out with Oak tree to be dug out.

ACTION: S Porter and P Fenwick to put it either on the green by the entrance to the Square to sit alongside the Duke Of Edinburgh Tree. Or it would go the other side of the road
