. Sycamore - Fell - Reason: Not a native species, overgrown for location, stunting plants underneath. If not fell, height reduction of 3m. Remove overhanging braches to the North

**Ref. No: 25/05657/CAT**

Group of Leyland cypress (G001) - Fell and grind stumps, due to excessive shading and ongoing maintenance requirements. Replant with copper beech hedging. Indian bean tree (T002) - Reduce height and lateral spread of crown to the north and west by approx. 1.5-2.0m, to provide clearance from garage. Common yew (T003) - Fell to ground level, to increase space for the adjacent cherry tree. Sycamore (T004) - Reduce height of crown by approx. 3.0-4.0m and lateral spread by approx. 2.0m, to prevent the risk of branch failure at historic pruning points. Sycamore (T005) - Fell to ground level, due to declining physiological condition. Treat stump to prevent future regrowth. Pit-tosporum (T006) - Fell to ground level, due to limited scope for future development. Group of Leyland cypress (G002) - Fell and grind stumps, due to excessive shading and ongoing maintenance requirements. Replant with common beech hedging. Cotoneaster (T007) - Fell and grind stump, due to poor form and to enable planting of new native hedging. Walnut (T008) - Fell and grind stump, due to excessive shading issues. Replant with suitable native species replacement. Prunus (T009) & Plum (T010) - Fell and grind stump, due to declining physiological condition. Oak (T011) - Crown lift to approx. 3.0m above ground level, to provide clearance over driveway and front lawn. Japanese cherry (T012) - Selectively reduce height and lateral spread by approx. 1.0-1.5m, to provide clearance from garage.
